Introduction

It is not yet clear why the study of Local Government communication is important to do in relation to democratization. And the reasons and arguments have not yet been drawn why the study was conducted in South Kalimantan and not in other regions in Indonesia

Literature Review:

Literature review is still not in line with the questions and research objectives. In addition, it is also necessary to be associated with theories of development communication, especially those related to Local Government

Methodology:

Be clear about the source of the data used especially those originating from documents. What documents are used as data sources. In addition, for in-depth interviews, there was no visible representation from the community such as community leaders or community officials at the local level

Findings & Interpretations:

The results section should be distinguished from the discussion section

Discussion:

The answer to the research question is not yet visible. This research has 2 main questions, namely: (1) Does the decentralization policy still have implications in the agenda and practices of government communication at the local level? and (2) To what extent does local government communication involve the participation of its citizens? This section has not shown clearly and clearly the answers to these 2 questions. In addition, the context of legislation also needs to be updated. Law 22 of 1999 is no longer in use at this time

You need to build problems from theoretical frameworks, previous research and data in the field

The literature review section has not been directed to building research assumptions / research hypotheses, researchers only write or describe the literature without relating it to "what is the problem" and "what are the temporary answers to be confirmed through this research"

Methodology:

Not valid methods

Findings & Interpretations:

Because not valid method, I decide it is not valid data. For example of being not valid method that there are not clear explanation about:

1. Turns out you researched the website. However, this is not mentioned at all in the beginning of your paper. This further shows that your research does not yet have a clear research gap and problem formulation

2. You wrote that the focus of observation is the website, but, for what interview? What is observation as a data collection technique? what's analyzed? Because the website is a document, then, what is the difference between the document data collection and observation techniques?

3. which part of the website are you researching? all? In what period? Who are your informants? Why was chosen as an informant? what is the relation of the informant to the website? How do you research a website? Content analysis? How to analysize?

Discussion:

Because it is not valid data so the discussion is not valid. Furthermore, the paper faliled to build propositions of the findings. It is only describing facts. So what for?

Discussion:

"Analysis of the results of in-depth interviews with six key informants and observations on the performance of the official website of the South Kalimantan Regional Government, http://www.kalselprov.go.id/ illustrates a comparison of perspectives from inside and outside relating to local government communication about public services in South Kalimantan." This was taken from the article - page 8.

Towards the end, the authors should include discussion on how those findings from in-depth interview related to each other and contributed towards local communication in government.

Second, the authors did mention about the ultimate objective of the paper (refer page 3); however, it's difficult to find the authors discussed about the quality of communication channels throughout the article.
