#### ANALYSIS OF ESG AND OWNERSHIP STRUCTURE OF FIRM VALUE WITH THE MEDIATION ROLE OF INVESTMENT DECISIONS

#### ABSTRACT

Investment decisions by investors and company management not only consider aspects of the company's financial performance but also relate to the company's sustainability on the environment as a responsibility for the environmental impact of the company's activities. The alignment of corporate responsibilities can be seen from the company's concern about Environmental, Social, and Governance (ESG). This study aims to analyze the effect of ESG and ownership otructure on firm value with the mediating role of investment decisions in energy sector companies on the Indonesia Stock Exchange (IDX). The research sample was 27 companies in the energy sector for the period 2017-2021 so that the total research data was 135 with sample selection based on purposive sampling. Analysis of research data using the Structural Equation Model (SEM) method with Partial Least Square (PLS) analysis technique. The results of the analysis found that ESG, ownership structure and investment decisions while ESG has no influence on investment decisions, therefore investment decisions only mediate the relationship between ownership structure and firm value while ESG only shows a direct relationship to firm value.
