In the last paragraph of the introduction, it is recommended that the objective of the article be written.

The introduction should not contain figures, tables, or graphs.

Obligatory or not.

Results and Discussion

Conclusion

In the conclusion it is recommended not to use quotes, because they are the authors' own words.

In the conclusion, return to the research question and answer it.

Also in the conclusion, the authors should reflect and show how the results obtained in this research can help society and academia.
